**Notice to All Interested Parties**  
**Proposed Availability of 2008 Competitive Grant Funds**

The Legal Services Corporation (LSC) is providing notice of the proposed availability of competitive grant funds to provide civil legal services to eligible clients during calendar year 2008. In accordance with LSC's multi-year funding policy, grant applications will be accepted for only specified service areas. LSC published the service areas in competition for 2008 funding in the Federal Register and at [www.ain.lsc.gov](http://www.ain.lsc.gov) on April 13, 2007.

The Request for Proposals (RFP) is available at [www.ain.lsc.gov](http://www.ain.lsc.gov). Once at the website, click on "Bulletin Board" to access the RFP and other important information pertaining to the LSC competitive grants process.

Pursuant to the LSC regulation governing the competitive grants process (45 C.F.R. 1634), a Notice of Intent to Compete (NIC) must be filed. Applicants must file the NIC by May 21, 2007, 5:00 p.m. E.D.T. The due date for filing grant proposals is June 14, 2007, 5:00 p.m. E.D.T.<sup>1</sup>

The following persons, groups, and entities are qualified applicants who may submit a NIC and an application to participate in the competitive grants process: 1) current LSC recipients; 2) nonprofit organizations that have as a purpose the furnishing of legal assistance to eligible clients; 3) private attorneys, groups of private attorneys or law firms; 4) state or local governments; and 5) substate regional planning and coordination agencies.
