NOTE:

(1) LSC FY 2010 Grantee Funding Levels are based P.L. 111-117, The Consolidated Appropriations Act, 2010. Prior to P.L. 111-117, Grantee Funding Levels were based on P.L. 111-88: Department of the Interior, Environment and Related Agencies Appropriations Act, 2010 (Division B is the Further Continuing Appropriations Resolution, 2010) which funded Basic Field at FY 2009 level: \$365,800,000 and an LSC decision to reallocate unobligated AS-1 2007 and 2008 Basic Field funds to all current grantees. Re: October 27, 2009 11:16 AM e-mail from the VP for Programs.

Unobligated 2007 and 2008 Basic Field funds for the AS-1 Service Area have been reallocated to the 2010 Basic Field funding pool. First, the Native American funding amount is deducted from the total Basic Field appropriation. Then these funds in the amount of \$552,457 are added to the remaining total before the allocation to Basic Field-General and Migrant funding amounts is calculated.

(2)As of January 1, 2010, service area OH-5 is being served by Ohio State Legal Services. Prior to December 31, 2009, Legal Aid Society of Columbus was the grantee. It voluntarily closed on December 31, 2009.

(3) Legal Services of Northern Virginia was the successful applicant for service area, VA-20, in the 2010 grant competition cycle. Prior to January 1, 2010, VA-20 was served by Potomac Legal Services. Potomac merged with Legal Services of Northern Virginia in late 2009..

(4) Legal Aid of Wyoming is funded for the first six (6) months of 2010 for WY-4, MWY and NWY-1, after which these three Service Areas are scheduled to be up for competition again.

(5) A funding decision for service area AS-1 is pending as of January 6, 2010. Also, please see note (1) above. AS-1 was not funded in 2009.
